- Intervals between cross section should not exceed maximum 25m and wherever profile correction coarse required suitable intervals should be taken. Cross section to be taken for the total ROW of the road.
- Berm cutting/filling, WMM,profile correction with BUSG, correction of camber and super elevation, BM and BC are the quantities to be given separately. Quantity to be worked out based on MoRTH/IRC specifications/requirements
- Quantity calculation and level sheet showing initial level, interim levels and proposed final level to be given with camber profile & super elevation.
- The profile /LS to be fixed with sufficient slope for easy drainage with location of drainage inlet from road surface and other required details.
- Wherever one side drain is only available slope of the road cross-section to be provided towards the drain irrespective of the standards geometrics for road construction.
- Liquidated damage of 5% of the contract amount per day will be levied for delay in submission.
- Payment will be done only on successful completion of the work.
- Late quotation (received after date and time of submission of bid) shall not be accepted under any circumstances
