Traffic integration and regulating the traffic at junctions ,Metro station and the Muncipal Bus Stand is also part of the enhancing the Metro Corridor.
- 1.2 As an initial step, topographic survey of Aluva by-pass including the service roads situated on the either side of flyover and Aluva Pulichode metro corridor have to be done on priority.
- 1.3 Kochi Metro Rail Ltd (KMRL), invites limited quotation for the work, "Topographic Survey of Aluva bypass to Pulinchodu Metro Station

### 2.0 Scope of work

- 2.1 Detailed topographical survey using total station and preparation of site plan of roads and taking cross section details at 30m intervals on straight roads and 15m on curves which includes details of center of BT, BT ends, Shoulders, drains, Right of Way, trees, Electric posts, buildings and any other manmade structures within the survey limits.
- 2.2 Location to be surveyed are given below
  - Aluva By pass junction (integrating the traffic and signals).
  - Service road, in front of Metro station upto Pulinchodu Signal Junction.
  - Area under the Aluva Flyover.
  - Service road from Pulinchode Jn via Market to Aluva By Pass Signal (Western side).
  - Approach road (NH) to fly over from Punilchode Jn.
  - Pulinchode Jn to Pulinchodu Metro Station (100 m towards south of Pulichodu Station).
  - Parking area of Aluva Metro Station integrating with Aluva Municipal Stand.



### 3.0 Deliverables

- 3.1 All the items mentioned below need to be mapped and Autocad drawings need to be submitted along with one set of copies
- Road RoW
- Tarred Portion of Road
- Building profile of the nearest building from the RoW on either side of road upto 5 meters from the outer edge of the building
- Landuse- Residential, commercial, etc. Existing entries/exit to be marked.
- Footpath edges and height(in meters)
- Traffic Signals
- Trees
- Storm Water Drains, its size, levels and location of manholes
- Electrical Post and Junction boxes
- Electrical supply lines
- Bus Stop footprint
- Location of viaduct pier locations
- All details required for preparation of good traffic plan and deviation plans.
