First Phase of Kochi Metro Project is now fully operational and now KMRL has been sanctioned with Phase II (JLN to Info Park) by Government of India covering approx. 11 km and having 11 stations.

KMRL intends to appoint a Fleet Supervisor on Re-employment basis, primarily for supervising the Feeder Bus and E-auto activities/functions of KMRL. Accordingly, applications are invited from experienced, dynamic and motivated persons for the post.
