Kochi Metro Rail Limited (KMRL), a 50:50 Joint Venture of Government of India and Government of Kerala incorporated for the implementation of the Kochi Metro Rail project and for its Operation & Maintenance. First Phase of Kochi Metro Project is now fully operational and now KMRL has been sanctioned with Phase II (JLN to Info Park) by Government of India covering approx. 11 km and having 11 stations.

KMRL intends to appoint a General Manager (Operations & Maintenance) E8 Grade on regular/deputation basis or on Re-employment basis as Chief Operations & Maintenance Manager or if suitable candidates are not found for General manager/Chief Operations & Maintenance Manager to recruit an Additional General Manager (Operations & Maintenance) on deputation basis or Addl. Chief Operations & Maintenance Manager equivalent to E7 Grade on re-employment basis, primarily for looking after the Operations & Maintenance functions of KMRL. Accordingly, applications are invited from experienced, dynamic, project oriented, result driven and motivated persons having required related experience and flair for maintenance of Engineering systems for the posts.
