The Government of India has applied for financing in the amount of US\$ 122.32 million equivalent from the AIIB toward the cost of the Kochi Metro Rail Project - Phase II, and it intends to apply part of the proceeds to payments for goods, works, non-consulting services and consulting services to be procured under this project.

The project will include the following components:

- Component 1 Civil Works. This will support the design and build of 11.2 km of elevated viaduct, including stations and tracks.
- Component 2 Railway Systems and Trains. This will support the procurement and installation of systems, including, among others: telecommunications, traction and power supply facilities, Supervisory Control and Data Acquisition (SCADA), auxiliary main substation, electrical and mechanical works, lift(s), and escalator(s).
- Component 3 Design and Implementation Support. This will support the procurement of detailed design consultants for the stations and traction systems, the independent safety assessor, and the general consultant.

AIIB will finance only the components 1 and 2, and the Component 3 is solely financed by the local funds from India.

Advanced contracting will be undertaken for the procurement of some of the packages under the components 1 and 2. AIIB approval of advanced contracting will not commit AIIB to subsequently approve the project, the project loan, the project costs, or to finance the procurement costs.

The procurement of the contracts financed by AIIB will be conducted in accordance with AIIB's Procurement Policies (January 2016, as revised in November 2022) and the AIIB's Interim Operational Directive on Procurement Instructions for Recipients (June 2016) and is open to all eligible firms and individuals.
