1. BACKGROUND

For demarcating the boundary of land by KMRL, it is decided to fence the land with GI Barbed wire fencing and develop the areas for Future Development Activities.

2. LOCATION OF SITE

Aluva, Edapally, Kaloor and as specified by Engineer in charge

3. SCOPE OF WORK

Scope of work consist of making up the material/irregularities on land by adding extra soil with roller compactor, Supply and Fixing 1.5m G.I barbed wire fencing with 2.1m angle post, Fixing of GI Gates as per direction of Engineer in Charge and as detailed in the drawing attached.

4. DRAWINGS

5. GENERAL TERMS AND CONDITIONS FOR BIDDERS

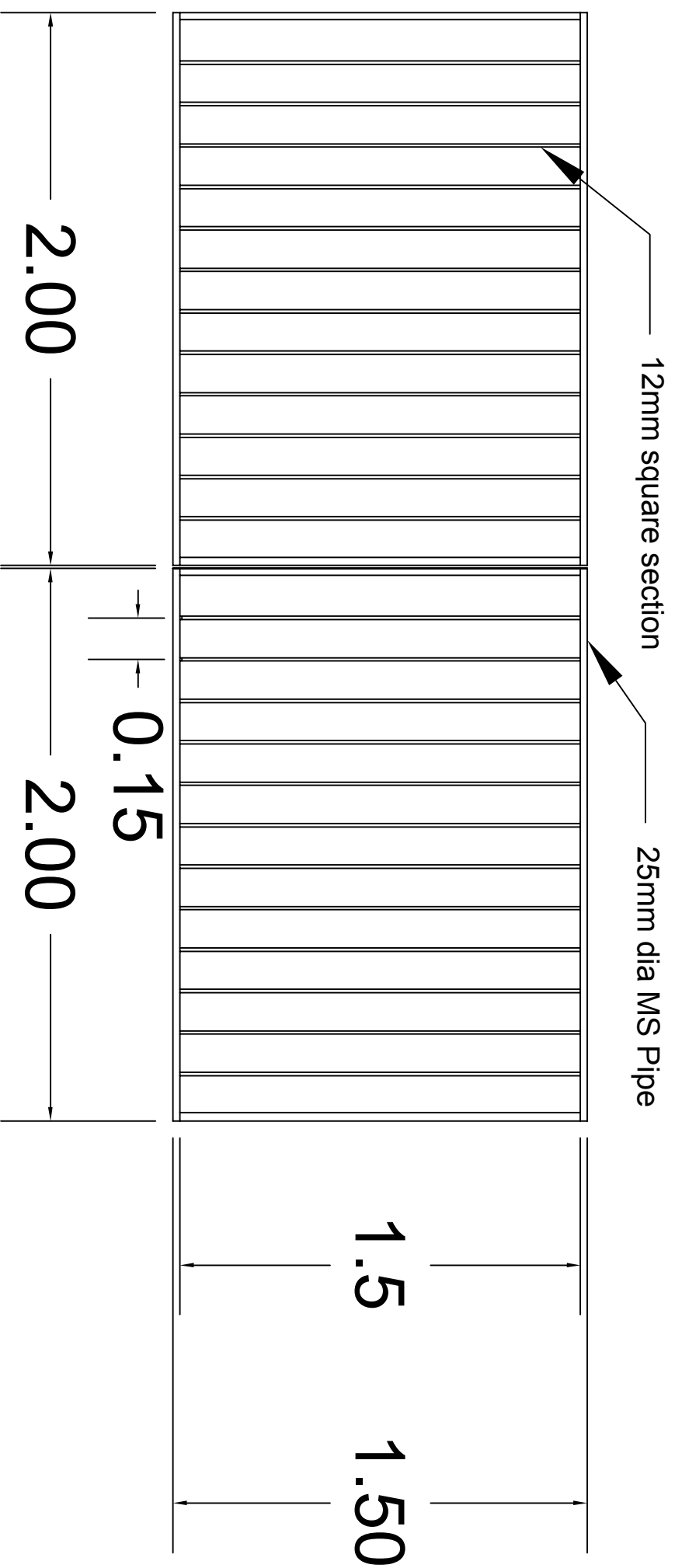
